## ACCIDENT WAIVER AND RELEASE OF LIABILITY

Please read carefully! This is a legal document and affects your legal rights.

I understand that the Dixie Social Club of Southwest Utah strives to provide a wide variety of activities such as: bowling, hiking, walking, pickle ball, picnics, parties, dances, games, breakfast/lunch/dinner groups, potlucks, road trips, *and other events/activities of any kind* and that such activities/events are held at a variety of locations to include but are not limited to private homes, businesses and/or public locations/lands. I acknowledge that the club cannot ensure, nor guarantee, that the activities I participate in or the events I attend will be free from hazards or accidents that could result in illness, injury, or death. I further acknowledge and agree that candid photographs and videos of me may be taken and may be shared with other club members or utilized to promote the club without my further permission and with no compensation.

I hereby assume all the risks of participating in any club activity/event. To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY the Dixie Social Club, its officers, directors, agents, and leaders from all liability on account of, or in any way resulting from injuries and damages, even if caused by negligence of the Dixie Social Club, its officers, directors, agents, and/or leaders. I further agree to HOLD HARMLESS the Dixie Social Club, its officers, directors, agents, and leaders from any claims, damages, injuries or losses caused by my own negligence while a participant in any club activity/event or as a member of the club in general. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns.

This waiver shall be construed broadly to provide a waiver and release to the maximum extent permissible under applicable law. I agree that if any clause or provision of this waiver and release shall be held invalid by any court of competent jurisdiction, the invalidity of such a clause or provision shall not otherwise affect the remaining provisions of this waiver and release, which shall continue to be enforceable. I agree that all claims or litigation arising related to any aspect of my past, present or future membership will be governed by the laws of the state of Utah.

I understand that this waiver and release is a requirement of membership and therefore applies to any time in which I am or have been a paid member of the club. I am at least eighteen (18) years of age, and I am under no mental or legal disability which would prevent me from signing and executing this agreement. I further represent that I have read (or someone has read to me) this waiver and release of liability and that I fully understand and agree to the terms of this agreement.
